



# Reedy Springs Pool Rules

**2023 Operating Dates; May 20<sup>th</sup> – September 10<sup>th</sup>**

**Pool Hours: 7:00 am – SUNSET**

**SWIM AT YOUR OWN RISK - NO LIFEGUARD ON DUTY**

## **SAFETY / HEALTH REGULATIONS:**

*In addition to the posted SC DHEC regulations, the rules below will be enforced to ensure all members and their guest(s) enjoy the community amenity. NOTE: Violations of these regulations can cause pool closure and/or fines as dictated by DHEC and the HOA*

1. No solo swimming or diving
2. No pushing, running, boisterous or rough play, spitting or nose blowing
3. **No glass allowed in pool or on pool deck area. Up to a \$1,000.00 fine (or total cost of maintenance to reopen pool) for broken glass that results in pool maintenance**
4. No persons under the influence of alcohol or drugs may use pool
5. No persons with skin, eye, nasal infections or communicable diseases in pool
6. **No animals or pets in pool or pool area**
7. No skateboards, hover boards, bicycles, scooters, roller blades or skates are allowed in the pool fenced area
8. No **WATER BALLOONS**

## **CHILDREN AT THE POOL:**

1. Children that are not potty-trained must wear rubber pants or "little swimmers" when in the pool. No diapers are permitted. Hygienic and economic reasons require strict enforcement of this policy
2. Children 6 and younger must be accompanied to restroom by adult
3. **Children 15 and younger may not enter pool or pool area without adult supervision (18 or older)**

## **HOUSEKEEPING RULES:**

1. Please close pool umbrellas after use and remove personal items upon exiting
2. Place all trash in receptacles
3. **NO SMOKING or VAPING** inside fenced area
4. No disruptive music
5. Do not place paper towels, diapers, etc. in the toilets

## **GUESTS:**

1. Number of guests is limited to 6 per household
2. All guests must be accompanied by an adult homeowner 18 or older

## **ATTIRE / ACCESS TO POOL:**

1. Proper swim attire is required to use the pool
2. Access to the pool is with an electronic key fob
3. New owners may contact CPM for a key fob. Replacement key fobs are \$30.00

## **POOL PHONE:**

1. Pool phone is for emergency purposes only.

**CAMERAS**

1. Pool area and entrances to restrooms are subject to 24/7 camera surveillance or recording.
2. Parking Lot is subject to 24/7 camera monitoring. HOA assumes no responsibility for monitoring.

**PARKING**

Residents and accompanying guests may use the parking lot during regular pool hours.

**WIFI and Hot Spot**

Available for residents during pool hours only. Name: SpectrumWiFi78. PW: gentlehorse820. If the resident has a Spectrum account that can be used to sign on. If the resident does not have a Spectrum account, they can sign on as a guest. In both cases, 30 minutes of free usage is available. Anything beyond 30 minutes will require the guest to pay for the usage through Spectrum.

**RESTROOM KEYS**

Men's and Women's restroom keys are located on key chains adjacent to the Pool rules Sign. They are intended for emergency use only (e.g. If a toddler locks itself in a restroom).

**FIRST AID KITS**

Located in Restrooms.

**FIRE EXTINGUISHER**

Located in THE Men's restroom.

**POOL ENTRY FOB'S**

Each owner/authorized tenant is provided with one Pool FOB. Please contact the management company during normal business hours for lost or inoperable FOB.
